Thank you for your ongoing leadership as Chair of the Ontario Arts Council (OAC).

To ensure that services are provided in accordance with your mandate and government priorities, I expect that OAC will align its planning with ministry priorities set out in my mandate letter, and establish strategies to support those priorities. OAC will focus on supporting the goals of the Ontario Culture Strategy, including contributing to an Arts Policy Framework and working with the ministry to develop and deliver the framework for the Indigenous Cultural Revitalization Fund; measuring and reporting on the progress of the OAC's "Vital Arts and Public Value: A Blueprint for 2014-2020"; and providing the

ministry with regular updates on the implementation of the new online granting system and streamlined granting programs.

To achieve and maintain the highest levels of accountability, OAC will work with the ministry to review and enhance governance, fiscal management and sustainability, and accountability processes to reflect best practices and ensure compliance with Treasury Board/Management Board of Cabinet direction as well as the new requirements with respect to executive salaries and compensation. The OAC will maintain an effective system of internal controls and compliance with applicable requirements to promote transparency and accountability, and will be required to manage any operational, strategic and financial risks to help ensure its business objectives are met.
